- 7.1 Y14/1057/SH Regency Cottage Sandgate- refused Y14/1210/SH Villa Medina Helena Corniche-approved with conditions
- 7.2 The assistant clerk said that two applications: Y14/1210/SH-Villa Medina Helena Corniche and Y14/1391/SH 28 Radnor Cliff had been mis-delivered into the spam folder and had therefore not been brought to the committee's attention. The spam folder would in future be checked more frequently. Cllr Prater said that there was a way to prevent certain emails being mis-directed into the spam folder and it was agreed that this action would be taken with immediate effect.

- **8.1** An email had been received from John Macauley, Planning Enforcement Officer regarding a query about the erection of garages at the side of 9 Riviera Court. The erection of garages had been as replacements for ones previously in situ but planning permission was needed and the owner had now requested to submit a retrospective planning application.
