This had not yet been established. The clerk was asked to find out who the owner is so that permission for using the side of the building for a display board could be sought. It was agreed that, should planning permission be given, the parish council would not proceed with the erection of the display board without first obtaining the owner's permission. Permission for the other sites had been received.

7. Information

The meeting ended at 7.03pm

- 7.1 Cllr Griggs informed members that he had attended the Taylor Wimpey exhibition last Friday. It was well attended. The information didn't show any significant changes to the traffic / congestion problems previously highlighted at the first exhibition last year.
- 7.2 At the exhibition, Cllr Griggs had a discussion with Ben Geering of SDC regarding S106 Agreements who said that the parish council should write to SDC with a request on what the money could be spent on to benefit Sandgate as a direct causation to the development. For example: bus, cycle and walking links. Mr Geering advised that this should be actioned within three to four weeks. The clerk was asked if this could go on the next main council meeting agenda.
- 7.3 SPC had been informed that CIL monies would not be available for this development. When CIL comes into force (probably in a year's time), SPC could ask for other aspects of Sandgate to benefit from these monies.
