

SANDGATE PARISH COUNCIL Minutes of a PLANNING COMITTEE MEETING Held at 6.00pm on Tuesday 31st March 2015

At Sandgate Parish Council/Library Offices James Morris Court, Sandgate High Street, Sandgate.

The meeting opened at 6.00pm. There were 12 members of the public in attendance.

- Minutes of the last meeting the minutes of the meeting held on 10th March 2015, having been previously circulated, were approved as a correct record and signed.

Cllr G Fuller decided to alter the agenda order due to the number of attendees present for agenda item 5 Land adjoining 14 The Corniche. So agenda item number 5 becomes number 4.

4. Land adjoining 14 The Corniche

Cllr Fuller said that he had met with interested parties regarding this item two weeks ago and informed them that this would be discussed the next Planning meeting.

Mr Loveday, the owner of the property, said he felt that attempts had been made to exclude him from the meeting, but Cllr Fuller explained that this was an open meeting advertised on parish council bulletin boards and the council website.

Mr Simon Dobson had asked to give a short presentation on behalf of a number the residents on The Corniche. Cllr Fuller agreed and asked that a copy of this presentation be sent to the parish clerk (*which has subsequently been done*). The presentation addressed concerns relating to land stability, drainage and ecological concerns. The parish council was asked to facilitate a thorough discussion between the residents and Shepway District Council.

Cllr Fuller thanked Mr Dobson for the 'excellent and informative' presentation and asked if there were any questions, statements or rebuttals from the audience. There were none.

Cllr Fuller said that an email had been received on 23rd March 2015 from Dave Sephton saying that concerns regarding the site were under investigation by SDC Planning.

Actions: The parish clerk was asked by Cllr Fuller to:

- Ascertain whether planning permission had expired
- Contact Building Control and get a statement regarding their position
- Contact Kent Highways for their views regarding the condition of the road
- Get a written statement from the tree officer Dave Sephton
- Contact Southern Water
- Contact Development Control regarding any soil investigation reports.
- Contact Mr Newcomb of Natural England –regarding the badger setts on site

Mr Loveday said that he had had two reports produced and Cllr Fuller asked if it would be possible if he could send them to the parish clerk.

Cllr Fuller also asked if there were any additional images of the site available. Cllr Prater said that it was crucial to gather all the information for further discussion and also crucial to ensure the safety and appropriate development of the area.

Cllr Fuller said that on receipt of all the required documentation, a further meeting would be convened. The attendees were asked to provide an email address if they would like to be informed about this meeting.

Cllr L Griggs said that he had spoken on the behalf of the parish council at the Development Control meeting last week. He said that this application had been approved with conditions. Cllr Griggs said that a good case had been presented regarding the Horn Street Bridge that indicated that the new signalling and development around the bridge would improve its condition and that the bridge would have been unviable in ten years' time without this work. Cllr Griggs also said the conditions had been put into place detailing the upkeep of heritage buildings and that the Sandgate Design Statement was to be referred to in later development plans.
