5. Town and Parish Councils Planning Group

- 5.1 Cllr Griggs informed the meeting that there had been discussions concerning E-Planning and problems utilising it.
- 5.2 He also discussed the time scale for the replacement of S106 by CIL in a year's time.
- 5.3 Cllr LG told the committee that SHLAA is to publish the results of the call for sites in July. Cllr TP noted that SPC had put forward some sites for protection.
- Planning law has been further relaxed with previously used agricultural sites being now permitted for use as certain classes of building i.e. nurseries.
- 5.5 When Shorncliffe Barracks' planning application is submitted, representations could be made to Shepway District Council.

6. Vine Cottage

The condition of the property was discussed as a member of the public had brought it to the attention of one of the councillors. It was also noted that a photograph of the house was prominently featured in the Design Statement as an illustration of the variety and beauty of local architecture in Sandgate. As the house was Grade II Listed, the committee asked the Parish Clerk to write to Alison Cummings at Shepway District Council to highlight the condition of the property. A letter had been received from a local resident, which was noted under item 8 of the agenda.

- 8.1 A letter had been received from Linda Rene-Martin, dated 5th May, concerning the dilapidated condition of Vine Cottage. It was previously circulated. This was noted and mentioned under item 6
- 8.2 A letter had been received from Euan Williamston, dated 30th April, regarding Y14/0489/SH Seacroft Lodge. This was previously circulated and was taken into consideration in the committee's deliberations under item 4.
- 8.3 A letter, dated 29th April, had been received from Tom Quaye regarding the Parish Council's objection to Y14/0145/SH 19A Encombe. The Parish Clerk was asked to write a letter of response to Mr Quaye stating that within the Parish Council's Terms of Reference three committee members is quorate; that flat roofs do not fit within the Key Design Characteristics set out in the Parish's Design Statement page 25, and that Shepway District Council officers do not report to the Parish Council committee.
- 8.4 An email had been received from Rebecca Chittock, dated 15th April, advising of the online location of the most recently revised list of Shepway's Development Plan policies.
