The Parish Council continues to object on the grounds of the previous application Y18/0308/SH namely: 'the lack of accessibility for both construction and normal use (as evidenced by Kent Highway's objection), concerns regarding land stability, adequacy of drainage locally, and over intensive development of the site.'

Although there are some welcome mitigations to the original application the Parish Council also object on the grounds that the west wing of the development in the garden still acts to the significant detriment of the conservation area.
