NOTICE OF PROPOSALS

Notice is hereby given that FOLKESTONE & HYTHE DISTRICT COUNCIL proposes the above Order under sections 32, 35 and 35c of the Road Traffic Regulation Act 1984 ("the Act"), having obtained the consent of Kent County Council in accordance with Section 39(3) of the Act, and of all other enabling powers, and after consultation with the chief officer of police in accordance with Part III of Schedule 9 of the Act.

The Order proposes the inclusion of the following car parks in The District of Folkestone & Hythe (Off Street Parking Places) Consolidation Order 2019 (as amended):

1. **West Hythe Car Park, West Hythe Road, Hythe**
2. **Fisherman's Beach Car Park, Range Road, Hythe**
3. **Hythe Swimming Pool Car Park, South Road, Hythe**
4. **Sea Wall Disabled Persons Car Park, High Street, Dymchurch**
5. **Dymchurch Village Hall Car Park, Orgarswick Avenue, Dymchurch**

The following charges and restrictions are proposed:

CAR PARK	Proposed Charges
West Hythe	Linear per minute charging Minimum stay 1 hour- £1.40 per hour Over 6 hours- £8.40
Fisherman's Beach	Free- Maximum Stay 4 hours
Hythe Swimming Pool	Free- Maximum Stay 2 hours
Sea Wall Disabled Persons Car Park	Free 3 Hours Maximum Stay for Disabled Badge Holders Only

This Order also proposes to:

- restrict access for petrol or diesel vehicles to Electric Vehicle Charging Bays in various car parks
- limit the length of stay of electric vehicles in Electric Vehicle Charging Bays to 4 hours during the operational hours
- extend the maximum stay limit for all vehicles in short stay car parks from 3 hours to 4 hours

Full details are contained in the draft Order, which together with the relevant drawings, a copy of any orders which will be amended by the proposed Order, and a statement of the Council's reasons for proposing to make the Order may be examined at The Council Offices, Castle Hill Avenue, Folkestone.
